

Comparison of the SSSCT and SSSIO Terms of Reference Documents

The SSSIO is NOT part of the Global Council. This decision was unanimous by the Prasanthi Council, SSSWF and all Zone Chairs.

Reasoning

The SSSCT has rejected the SSSIO's proposed Terms of Reference for the SSSGC and abruptly terminated all further discussions.

- The differences are based on the agreement signed by the three organizations in the Joint Statement issued on May 31, 2021, that there will be no change in the structure and functioning of the SSSIO.
- The SSSIO sees the SSSGC as a unifying, coordinating and consulting forum. This preserves the structure and function of the SSSIO; the Organization that Swami has founded and continues to operate under His guidance for over 50 years serving devotees in 119 countries.
- The SSSCT sees the SSSGC as a unifying, coordinating and SUPERVISING body.
- The SSSIO's firm and total allegiance is ONLY to Bhagawan Sri Sathya Sai Baba and to Prasanthi Nilayam now and for the future.

Reasoning

This protects the structure of the SSSIO as established by Bhagawan.

SSSIO Function is Altered by the SSSCT

SSSCT Version of SSSGC

Claims SSSGC as the supervising and appointing body for all the officers of all the organizations.

SSSIO Version of SSSGC

Removed this role of the SSSGC for SSSIO officers. (Section III, M, 1)

Reasoning

Because the existing bylaws and protocols given by Swami have a mechanism to appoint all officers. We do not want to disobey the Divine Command of Bhagawan.

SSSCT Version of SSSGC

Presents that any future amendments to the TOR can be made by unstated authority of the SSSGC.

SSSIO Version of SSSGC

Directs that any future amendments to the TOR can only be made by unanimous vote of the SSSGC. (Section III, M, 6)

Reasoning

This protects the structure and functioning of the SSSIO as established by Bhagawan.

 - a. All the Zonal chairs will be appointed under the signature of the Chairman, SSSGC.
 - b. All the Country heads, Central Coordinators and Regional Coordinators will be appointed under the signature of Chairman, SSSIO
 - c. The various office bearers and the members of all the committees at zonal level will be appointed under the signature of Zonal chairs.
- 3. Selections, appointments, extensions, reappointments and removals of all SSSSO officers including the All India President of SSSSO, National Council Members, National Coordinators, State Presidents shall continue as per their bylaws & protocols and within the Executive Committee-2 of SSSGC:
 - a. All the National Council members of SSSSO will be appointed under the signature of Chairman, SSSGC.
 - b. National Coordinators, State Presidents and other office bearers will be appointed under the signature of All India President, SSSSO.
- The Executive Committees can draw any devotee, expert, or former 4. office bearer to play any role in the functioning of SSSGC and also appoint them to the subcommittees of SSSGC, as and when required.
- 5. Sai organisations in any country outside India will be under the SSSIO.
- 6. Any revisions to this TOR must be by the deliberations in the SSSGC **Executive Committees.**

 - a. All the Zone Chairs, Central Coordinators, Deputy Central Coordinators, National Council Presidents, and Committee Chairs will be appointed by and under the signature of Chairman, SSSIO.
 - b. The various office bearers and the members of all the committees at zonal level will be appointed under the signature of Zonal chairs.
- Selections, appointments, extensions, reappointments and removals 2. of all SSSSO officers including the All India President of SSSSO, National Council Members, National Coordinators, State Presidents shall continue as per their bylaws & protocols and within the Executive Committee-2 of SSSGC:
 - a. All the National Council members of SSSSO will be appointed under the signature of Chairman, SSSGC.
 - b. National Coordinators, State Presidents and other office bearers will be appointed under the signature of All India President, SSSSO.
- 3. None of the three Organisations will have veto powers over any other Organisation in any matter, including the power for appointments and removals of officers, and will respect the autonomy of each Organisation.
- 4. Sai organisations in any country outside India will be under the SSSIO.
- 5. Any revisions to this TOR must be by the deliberations in the SSSGC Executive Committees and can only be made by a unanimous decision of Executive Committee members.

- 6. Zone leaders of the Medical wing will be members of the Medical Subcommittee of SSSGC.
- A group of education experts from the zones will be the members of 7. the Education Subcommittee.
